A Travel Consent Form is used when a child is traveling alone, with only one parent/legal guardian, or with an authorised group. This document notifies authorities or other interested parties that a parent or legal guardian has given their consent for the child to travel without them. This document can be used both for domestic travel inside the UK or international travel across country borders.

The child travel consent form is used for any minor that has permission from their parent or legal guardian for domestic or international travel with someone else, group, or organization. In addition, this is also common when the child is traveling alone. It's

preferred to have the consent form signed by both parents although one (1) is sufficient.

Documentation requirements become more complicated when one parent or guardian is traveling alone with a minor. In general, besides your passport, you should bring written consent from the child's biological parent(s) along with the child's birth certificate. Many countries require that the consent document be witnessed and notarized.

Required Documents for International Travel With Minors

If a minor child is traveling outside the United States with someone other than either legal parent, BOTH legal parents should sign this form. If one or both legal parents are deceased, a certified death certificate should be attached to this form.

INSTRUCTIONS FOR PARENTAL/GUARDIAN ... - Single Parent Travel

Children Traveling With One Parent Or With Someone Who Is Not A Parent Or Legal Guardian. If a child (under the age of 18) is traveling with only one parent or with someone who is not a parent or legal guardian, U.S. Customs and Border Protection (CBP) strongly recommends that the accompanying adult have a note from the non-traveling parent (or, in the case of a child traveling with neither parent, a note signed by both parents) stating "I acknowledge that my wife/husband/etc. is traveling ...

Children Traveling With One Parent Or With Someone Who Is ...

An immigration officer, airline, or travel company may ask for a letter of consent if the child is traveling internationally with only one parent or with another adult, such as a relative, friend, teacher, etc. You can download the minor travel consent form in PDF format at the bottom of the page. See our Q&A parental consent. U.S. citizen children under the age of 19 arriving by land or sea from Canada or Mexico and traveling with a school group, religious group, social or cultural organization or sports team, may present an original or copy of their birth certificate, a Consular Report of Birth Abroad, or a Naturalization Certificate.

But if your minor child will be traveling out of the country alone, with one parent, or with someone other than a parent or legal guardian, he will likely need to carry a notarized letter of consent (and perhaps a medical letter of consent) signed by his parents in addition to the unaccompanied minor program paperwork.

Free Consent Forms for Minors Traveling Without Parents

If the child is travelling with both birth parents, a Child Travel consent should not be needed. However, in any other situation (for

example, the child is travelling with only one birth parent, or a grandparent or other guardian), a Child Travel Consent is recommended, especially for international travel.
