This figure is 1.22 times higher than the mean household size-adjusted income among men who are blind in both eyes (\$25,503). Men with other visual impairments had a mean household size-adjusted income of \$29,504, which is 1.16 times the mean household size-adjusted income of men who are blind in both eyes.

## EMPLOYMENT AND ECONOMIC CONSEQUENCES OF VISUAL IMPAIRMENT ...

When children and adults apply for disability benefits and claim that a visual impairment has limited their ability to function, SSA is required to determine their eligibility for blindness and disability benefits (see Appendix C for a glossary of terms used in reference to SSA disability programs). To ensure that these determinations are made fairly and consistently, SSA has developed criteria for eligibility and a process for assessing each claimant against the criteria.
